I HEREBY AUTHORIZE STUDIO ONE DANCE COMPANY STAFF TO ASSIST WITH TEMPORARY FIRST AID TO MY CHILD OR CHILDREN IN THE EVENT OF ANY ILLNESS AND SEEK MEDICAL AID IN THE EVENT OF AN EMERGENCY. I UNDERSTAND I AM RESPONSIBLE FOR MEDICAL EXPENSES INCURRED THROUGH ILLNESS, ACCIDENT, OR INJURY.

**PAYMENT POLICY:** BY SIGNATURE OF THIS WAIVER AND AGREEMENT, I UNDERSTAND *REGISTRATION AND CLASSES ARE NON-REFUNDABLE, NON-RETURNABLE.* CREDIT IS APPLIED TO MY ACCOUNT FOR CLASS CREDIT ONLY. PAYMENTS MUST BE MADE WITHIN 2 WEEKS OF DATED INVOICES OR UNLESS DISCUSSED WITH KELLY SKAGGS, OWNER OF STUDIO ONE DANCE COMPANY. FAILING TO PAY ANY OUTSTANDING INVOICE WILL RESULT IN 1) LATE FEES OF \$5.00 PER CLASS, PER WEEK TO BE APPLIED TO THE OUTSTANDING INVOICE AND 2) ANY PREVIOUS DISCOUNTS GRANTED WITHIN THE DANCE SEASON WILL BE NULL AND VOID AND THE DIFFERENCE WILL BE OWED TO STUDIO ONE DANCE COMPANY.

**ABSENCE POLICY:** CLASS FEES ARE NON-REFUNDABLE AND NON-RETURNABLE. IN CASE OF ABSENCE, STUDENT MAY MAKE UP THEIR DANCE CLASS. REFUNDS AND TUITION ADJUSTMENTS ARE NOT AVAILABLE.
